Mount Pleasant Neighbourhood House is looking for experienced, passionate, and values-based Early Childhood Educators to join our growing team as Infant, Toddler, 3-5 room Leads (4 positions in total). Under the general direction of the Childcare Director and the Early Years Coordinator the Lead Educators will assist with the start-up of a 69- space Childcare Centre located on the rooftop of Eric Hamber Secondary School which is scheduled to open in April 2025 and will serve families with infants, toddlers and preschool aged children.

MPNH is a member of the Association of Neighbourhood Houses of BC (ANHBC). ANHBC Childcare Programs are inspired by the BC Early Learning Framework and the Reggio Emilia Approach. This is an exceptional opportunity to help lead the way and co-create an inspirational Early Learning Program. The right person for this position is passionate about community development, social justice and is values-aligned with our organization.

### About You

You are passionate, creative and have an eagerness to work as part of a collaborative, supportive and dynamic team in a non-profit and volunteer-based organization. You are inspired by the Reggio Emilia approach and the BC Early Learning Framework. You are knowledgeable of evolving philosophies and pedagogies in early childhood care and education, including risky play, decolonizing early childhood spaces and are up to date with current trends, policy and changing perspectives on work with young children.

You are passionate about creating inclusive early learning spaces, believe children learn best through play and enjoy being outside with children in all weather, gardening and exploring the community. You have experience leading a team through collaborate dialogue to support

children's inquiries and learning, and you value the role of pedagogical narration in your practice. You possess strong planning, organizational, leadership and communication skills. You have a desire to help lead the way as part of an exciting new centre that will be inspiring, nurturing, and innovative.

### **About the Positions**

The Lead Educators will be responsible for the leadership, supervision, and administration of their specific programs. Team Leads will have opportunities to work collaboratively and with the Coordinator and Director to explore and implement innovative programming and nurture a progressive early years culture in the new centre. Lead Educators must have the ability to effectively supervise staff, volunteers and practicum students. The position requires the ability to adapt to changing circumstances, handle emergencies skillfully using discretion and confidentiality.

- Minimum 3 years of experience in licensed childcare in a leadership role.
- Solid knowledge of the BC Early Learning Framework and the Reggio Emilia Approach.
- Excellent understanding of the BC Child Care Licensing Regulation.
- Strong planning, organizational and time management skills.
- Excellent and proficient oral and written communication.
- Strong planning, organization and admiration skills.
- Passion and commitment for ongoing professional development and growth and exhibiting leadership in this area for other educators.
- Ability to adapt to changing circumstances, handle emergencies skillfully using discretion and confidentiality.
- Creativity, critical thinking, flexibility and sense of humour.

#### Terms

- Regular full-time positions -35 hours per week. Regular part-time position- 32 hours per week.
- Rotating shifts between 7am to 5:45pm Monday to Friday. 7 hours direct service, 1 hour unpaid break.
